They are encouraged to participate in national and international legal research paper presentations and publish in reputed journals. Additionally, specialized workshops and seminars on niche topics, such as intellectual property law, international arbitration, Contract Drafting and Pleading have been organized. Guest lectures by legal luminaries provide an excellent platform for fast learners to engage in-depth discussions and gain insights into advanced legal practices.

Fast learners are actively engaged in higher-level moot court competitions and mock trials, focusing on intricate issues like constitutional challenges and international law. They are also given opportunities to act as judges or mentors for junior students, honing their evaluative and leadership skills. Case analysis and opinion writing are emphasized, with assignments requiring in-depth analysis of legal judgments and drafting of legal opinions. Students are encouraged to critically examine recent Supreme Court and High Court rulings, which fosters critical thinking and legal reasoning.

A peer mentorship program has been introduced, pairing fast learners with peers or juniors who need academic support. This initiative not only benefits the mentees but also enhances the mentors' understanding of legal concepts through teaching. Study groups led by fast learners further stimulate discussions on complex legal topics. Legal tech exposure is another vital aspect, with students gaining hands-on experience with e-discovery tools, legal analytics, and contract automation software.

Participation in legal aid clinics provides real-world problem-solving opportunities for fast learners. These students assist underprivileged clients and handle pro bono cases under faculty supervision, often assuming leadership roles. Advanced certifications in specialized areas such as Contract Drafting, and Mediation are recommended, encouraging students to deepen their knowledge. Fast learners are also involved in curriculum development, contributing to reviews and designing new legal projects and assignments.
