



Analysis of the questionnaire distributed at the Environment Awareness Rally

The questionnaire distributed during the environmental awareness rally aimed to assess participants' understanding of key environmental issues and their actions to preserve the environment. The quiz focused on practical actions related to reducing plastic waste, pesticide use, energy conservation, water conservation, and global environmental observances such as World Environment Day.

One of the key findings from the survey was that the majority of participants (80%) correctly identified that using reusable bags and containers is an effective way to reduce plastic waste. However, a smaller portion (15%) still opted for plastic bags, indicating a need for more awareness about sustainable alternatives to single-use plastics. When it came to the use of chemical pesticides in gardening and farming, 70% of the participants understood that pesticides harm vital pollinators like bees, which are essential for food production. Nevertheless, 20% of respondents were unaware of this connection, revealing a gap in understanding the ecological consequences of pesticide use.

In terms of energy conservation, 85% of participants correctly understood that conserving energy reduces the need for fossil fuels to generate electricity. This strong response indicates a solid grasp of the relationship between energy consumption and environmental impact. However, 5% of respondents mistakenly believed that energy conservation increases air pollution, signaling some confusion that may need to be addressed in future campaigns.

Regarding water conservation, the majority (75%) of participants answered correctly, recognizing the importance of taking shorter showers or using low-flow showerheads. Yet, 10% still believed it was acceptable to water the garden daily, even if it was raining, which highlights a need for further education on water usage and its environmental consequences. When asked about the date of World Environment Day, only 60% answered correctly, with some confusion surrounding the date, as 25% of respondents selected incorrect dates. This suggests that, despite the global significance of the day, many participants lacked awareness of this important observance.



Overall, the survey revealed strong awareness of key environmental actions, particularly in areas like reducing plastic waste and conserving energy. However, gaps were identified in water conservation practices and knowledge about global environmental observances like World Environment Day. To address these gaps, future environmental awareness campaigns should focus on providing clear, actionable advice on water conservation, promoting eco-friendly alternatives to pesticides, and enhancing knowledge about important environmental dates. These steps could help further empower the community to take meaningful action toward preserving the environment.



Street Play – 6th November 2023

On 6th November 2023, the Department of Lifelong Learning and Extension of Children Welfare Centre's College of Law in association with Inspiring Indian Women (IIW) NGO, had organized a Street play at Brihanmumbai Municipal Corporation, Kabaddi Maharshi kai. Shankar Salvi maidan, Malad (e).

The street play was organized to create awareness about topics such as domestic violence, Women empowerment and internet safety. The event aimed to engage the community in a thought-provoking and entertaining manner, utilizing the power of street theater to convey important messages.

Each topic was taken up by one group comprising of 10-12 members and accordingly 3 groups presented 3 plays. The first play was presented on the topic of domestic violence. The play followed the life of a married couple where the husband used to torture his wife for dowry. Through their performance, students demonstrated effective ways for women to address this challenging situation, and emphasized the importance of seeking assistance from relevant authorities instead of accepting violence as a normal part of their lives

The topic for the second play was Internet safety. Internet has become an integral part of our day to day lives and functioning without it is almost impossible. However, just as a coin has two sides, the internet, despite its significance, brings along its own set of disadvantages. The students illustrated these pros and cons through a series of short stories within their play. Ultimately, the play concluded by conveying a message to the

Analysis of the questionnaire distributed at the Environment Awareness Rally

The survey conducted during the election awareness rally aimed to assess the public's understanding of the importance of voting and the voting process. It focused on raising awareness about why voting is a civic duty, the age requirements for voting, the necessary identification to cast a vote, and the significance of both national and local elections.

The majority of respondents (85%) correctly understood that voting is an essential civic duty because it allows individuals to voice their opinions and choose their leaders. However, a small percentage (10%) still believed that voting is only for people interested in politics, indicating a misunderstanding of the broader civic importance of voting. Regarding eligibility, 90% of participants correctly identified that voting is generally allowed at age 18, while 5% mistakenly thought the voting age was higher, highlighting some confusion around the legal age requirements.

A common barrier to voting identified by the survey was the belief that one's vote doesn't matter. Seventy-five percent of respondents recognized this issue, which is a key factor in voter apathy. In contrast, a small group (10%) incorrectly thought that people don't vote because they are required to do so, showing a lack of awareness about voluntary voting in most countries. Regarding the necessary identification to vote, 80% of respondents knew they need a government-issued ID or voter ID card, although 15% mistakenly thought a passport was required. This indicates a need for clearer voter education about the identification process.

When asked about local elections, 85% of participants correctly understood that voting in local elections allows people to choose leaders who make decisions that directly impact their communities. However, 10% thought that local elections only affect national issues, and 5% believed that local elections were relevant only to big cities. This suggests that while the majority understands the importance of local elections, further education could be beneficial to clarify their impact.

Overall, the survey showed that while there is a strong understanding of the importance of voting, some areas still need attention, particularly in reducing voter apathy, clarifying voter registration and ID requirements, and emphasizing the significance of local elections. To improve voter participation, future awareness campaigns should focus on educating people about how every vote counts, ensuring that voter requirements are clear, and raising awareness about the importance of local governance. This will help empower citizens to actively participate in the electoral process, knowing their vote can make a difference.

The second method discussed by Sir is the website portal www.eci.gov.in. This online platform offers a simplified enrollment process. Emphasizing the importance of keeping the reference number saved, Sir explained that, given the online nature of the process, it is



crucial to have the reference number on hand for seeking assistance effectively.


