

- 5) The Meeting also decided to authorise the appointed advocate to proceed for registration of the Alumni Association under the provisions of the Societies Registration Act .

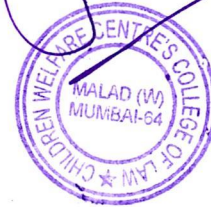
Conclusion: The Alumni Convener suggested the tentative date for the next meeting according to the availability of the schedule .The meeting ended with a formal vote of thanks.
