



Faculty Development Programme on “Innovative Pedagogies and Effective Classroom Management.” -13th and 14th October 2023.

The programme aimed to enhance the pedagogical skills of faculty members, encouraging collaborative learning and fostering innovative teaching practices. The event was inaugurated by our esteemed Principal, Dr. Anant Namdeorao Kalse, who highlighted the critical role of educators in shaping future legal professionals. In his keynote address, he emphasized the need for continuous professional development to adapt to the ever-evolving landscape of education.



Faculty Development Programme on “Building Synergy for Institutional Excellence” – 4th and 5th August 2023





Report on Seminar: A Legal Research Database Orientation *on* 17th October 2023

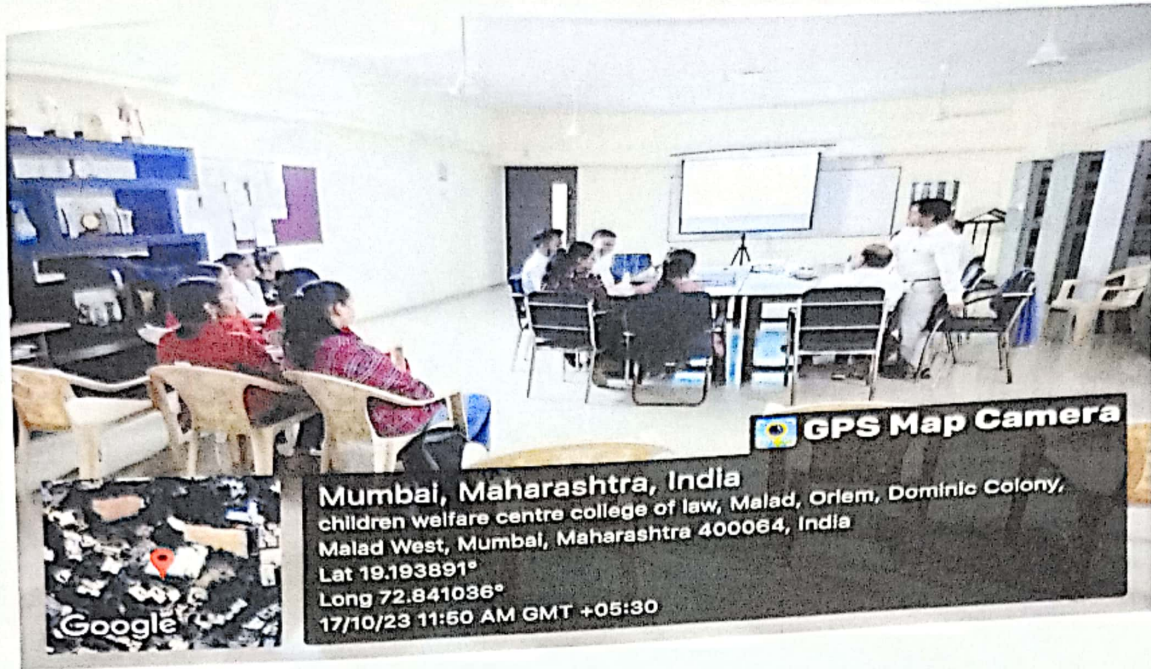
