INTRODUCTION OF ANTI- RAGGING:

The Supreme Court defined ragging in the case of Vishwa Jagriti matter (1999) as " Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or indiscipline activities which causes or is likely to cause unrest.

AIM OF ANTI-RAGGING COMMITTEE:

1. To prevent, Prohibit and redress any and all forms and instances of ragging in the College.
2. To educate the students on the meaning of ragging and what constitutes it?
3. To prevent, Prohibit and redress any and all forms and instances of ragging in the College.
4. To educate the students on the ill-effects of ragging and the consequences, including legal consequences of indulging in ragging.
5. To aware the students of dehumanizing effect of ragging inherent in its perversity.
6. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
7. To improve and prevent negative impact on other students and protect the interest of all the students.
8. To Prohibit and redress any and all forms and instances of ragging in the College.
9. To contribute to the efficient operation of an organization with effective communication of information and assisting the leadership in the decision-making process by providing needed information.

OBJECTIVE OF THE ANTI-RAGGING COMMITTEE:

1. To make the rules and regulations as per the anti-ragging requirement.
2. To make the students aware about anti-ragging
3. To make the student follow the anti-ragging disciplinary rules.
4. To take disciplinary action against any of the misconduct.

GOALS OF THE ANTI-RAGGING COMMITTEE:

1. The main purpose of the disciplinary action should be to correct unacceptable behavior and not to punish them.
2. The cornerstone for anti-ragging committee should be rehabilitation and corrective action.

PROCEDURE TO BE FOLLOWED BY THE ANTI-RAGGING COMMITTEE:

The anti-ragging committee should follow five stages in its procedure in order to have proper disciplinary action.

1. Verbal warning
2. Written warning
3. Final written warning
4. Dismissal from college.
5. Any other disciplinary action that the college or institute may deem fit and proper, on case to case basis.

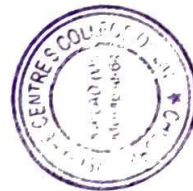

Anti-Ragging Committee

Introduction:

The Indian Penal Code and the UGC Regulations on reducing the scourge of ragging in Higher Education Institutions, 2009, provide that ragging is strictly prohibited and that anybody found guilty of engaging in or aiding in ragging may face penalties. Any act of ragging is forbidden and penalized under "The Maharashtra Prohibition of Ragging Act, 1999 (Mah. XXXIII of 1999), published in the Maharashtra Govt. Gazette on May 15, 1999." Any student who is discovered engaging in ragging should be reported right away to the University of Mumbai's Anti-Ragging Monitoring Cell, the College's Anti-Ragging Squad, the Coordinator, or the Member of the Anti-Ragging Committee.

In addition, these pupils will be dismissed from the college, and a police F.I.R. will be filed against them. An Anti-Ragging Committee has been re-established in the college as required by the Maharashtra Prohibition of Ragging Act, 1999, to help authorities combat the problem of ragging. The committee will assist the college administration in making decisions regarding any issues pertaining to ragging.

Ragging is a criminal offence. Both the Central Government and the State Governments firmly forbid ragging. The following will be the consequences for ragging:

- (i) Imprisonment up to three years and fine of Rs.50,000/-
- (ii) Dismissal from the college

Objectives:

- o To prohibit, prevent and eliminate the scourge of ragging including any conduct by any student whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student.
- o To monitor, direct and oversee the functions and performance of the Anti-Ragging Squads in prevention and curbing of ragging in the institution.

Function:

- To be vigilant at all hours all around the campus and other places vulnerable to incidents of, and having the potential of ragging and shall be empowered to inspect such places.
- To make surprise raids on hostels, and other places vulnerable to incidents and having the potential for ragging.
- To conduct an on-the-spot enquiry into any incident of ragging referred to it by the faculty or student or parent or guardian, as the case may be: and the enquiry report along with recommendations shall be submitted to the Head of the Institution for action.
- To ensure the display of posters on Institution and Department Notice Boards and other prominent designated places.
- To offer services of counselling and create awareness to the students.
