Meeting Review:-

1. The Committee put forth_ the proposal to install CCTV cameras across various locations on campus, particularly in areas that are poorly lit or have been identified as security risks (e.g., parking lots, stairwells, and back entrances). The plan will cover all major entry and exit points, corridors, classrooms, and common areas, with a focus on places that are typically less visible or monitored after working hours.

- 2. The Committee discussed the need for better student amenities, including additional parking spaces and recreational facilities. The committee put forth the proposal to will explore options for expanding parking, including the possibility of constructing multi-level parking and further, proposed plans for expanding recreational facilities and designing new spaces for student relaxation and physical activities
 - 3. The committee put forth the proposal to conduct mandatory workshops on sexual harassment awareness for both students and staff. These workshops aim to educate and raise awareness about what constitutes sexual harassment, its legal implication. Informing both students and staff about how to report incidents of harassment and the procedures for handling complaints.
 - 4. The committee proposed the installation of a complaint box within the college premises to facilitate the submission of complaints and grievances related to women's issues confidentially. It was suggested that the complaint box be placed in a discreet but accessible location, such as near the WDC office or the student
 - 5. The proposal to install projectors in classrooms was presented. The member highlighted the need for incorporating modern technology to facilitate better presentations, digital learning tools, and remote learning opportunities. A projector in each classroom would aid faculty members in conducting more engaging lessons using multimedia resources such as videos, presentations, and digital documents.
